Collection of your Personal Information

This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. All such third parties are prohibited from using your personal information except to provide these services to ASE, and they are required to maintain the confidentiality of your information.

Use of Cookies

The ASE Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize ASE pages, or register with

Associazione ASE site or services, a cookie helps ASE to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same ASSOCIATION ASE Web site, the information you previously provided can be retrieved, so you can easily use the ASE features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the ASE services or Web sites you visit.

Security of your Personal Information
